

Camping regulations Strandcamping de Zwinhoeve 2025

Strandcamping de Zwinhoeve is affiliated with HISWA-RECRON. As a result, the general HISWA-RECRON conditions for tourist places that can be found on the website apply to this campsite. In addition to these general terms and conditions, we also apply the regulations of Strandcamping de Zwinhoeve.

Article 1: The tourist place

On the day of arrival, the pitch is available for you from 13:00. You can pick up the key to the private unit from 3 p.m. You must leave the place before 11 am on the day of departure. If this does not happen, we will charge an extra day.

Article 2: Payment method

If the payment is not in our possession before the set date, we reserve the right to cancel your booking in accordance with the HISWA-RECRON conditions.

Article 3: Conditions

On arrival, the holiday maker must report to the reception (during opening hours). If there are changes in the persons you have specified, this must be communicated upon arrival.

Article 4: Access control

- 1. Each tenant of a pitch receives an access card to operate the barrier upon arrival at the campsite. On departure, you must deposit the card in the mailbox at the barrier or hand it in at the reception. If you have also received a key, you must also return it.
- 2. It is expressly not allowed to pass on the card to third parties: they must first report to the reception. If we find that you do pass on your pass, we will block it.

In addition to the barrier pass, you also receive a shower pass per person. The card has been charged by us, so that you can shower 2 times per day per person (5 min. per shower). If you want to use the launderette, you must load the card with money. You can do this next to the entrance of the reception.

Article 5: Family camping only

Young people under the age of 21 are not allowed on the campsite without their parents or legal guardian.

Young people under the age of 21 may only stay on the campsite if at least one of their parents or legal guardians is present on the campsite and as long as the young people stay on the same field as their parents. Groups make reservations on request only.

Article 6: Day visitors

- 1. Day visitors must leave the campsite by 11 p.m. at the latest. Make sure your day visit follows our rules. We consider you responsible for the behavior of your visitors.
- 2. Visitors are not allowed to enter the campsite with their car. They can park it outside the campsite in the parking lot of the municipality (the municipality of Sluis charges parking costs for this).

Article 7: Pets

It is allowed, subject to consultation, to bring a maximum of 2 pets to the campsite. The condition is that the dogs are kept on a leash at all times, are not left alone and are walked outside the campsite (remember the duty to clean up). Violation of the rules will irrevocably lead to an immediate end to your stay at the campsite.

Article 8: Camping pitch

- 1. A maximum of 1 additional tent of max 4m2 per pitch is allowed.
- 2. Placing a party tent is only permitted in consultation.
- 3. A maximum of 6 people are allowed per pitch (including babies).

- 4. Campers are only allowed on the appropriate camper pitches. The weight must be known at the reception. Not all campers can park on the camper pitches.
- 5. There is one camper service station where you can only discharge water, no chemical toilet.
- 6. Chemical toilet can be discharged in the appropriate places.
- 7. On departure, the private sanitary facilities must be left clean and you must hand in the key at the reception or put it in the mailbox.
- 8. A groundsheet may not be placed under the extra awning.

Article 9: Fire hazard

It is not allowed to make open fire, such as braziers and/or fireplaces. Barbecuing is allowed until 10:00 PM, provided it is done in a safe manner and does not cause a nuisance to other residents. Always keep a fire extinguisher or bucket of water at the ready!

Article 10: Car or motorcycle use

- 1. We request that you limit car or motorcycle use to a minimum and only drive at walking pace. The car or motorcycle must be parked on your spot. One car can/may enter the campsite per access card issued. To minimize the use of the car, an anti-passback system is present on the barrier installation. As a result, you cannot leave the campsite until 8 minutes after entering.
- 2. It is not allowed to charge electric cars on the campsite. You can charge it on the Duinweg at the appropriate charging stations. Note: this is paid parking.

Article 11: Go-karts, hoverboards, scooters, etc.

Go-karts, hoverboards and powered scooters are allowed provided they are driven at a walking pace. Sit-on hoverboards are prohibited throughout the campsite. This is for the safety of the drivers and all other guests at the campsite.

Article 12: Drones

To ensure the privacy of our guests, the use of drones is not allowed.

Article 13: Rest

- It should be taken into account that it should be quiet on the campsite between 11 p.m. and 7 a.m. It is not allowed to drive over the campsite with cars or other motorized vehicles (the barrier can no longer be opened). Noise nuisance in the broadest sense of the word must be avoided at all times.
- 2. After the reception has closed, in case of emergency, you can use the intercom at the main entrance of the campsite to inform the manager.
- 3. The management reserves the right to deny the person(s) concerned access to the campsite in the event of repeated nuisance.

Article 14: Shower and toilet facilities

- 1. Keep the toilets and showers clean!! Children up to the age of 6 are not allowed to go to the toilets unaccompanied. Do not dispose of sanitary napkins, diapers, wet wipes, etc. in the toilets.
- 2. It is not allowed to clean vegetables, fish, etc. in the washbasins inside the toilet building.
- 3. Smoking is not allowed in the buildings.

Article 15: Waste processing

The campsite offers good options for separating waste. You must deposit your household waste in tied bags in the containers and then close the container again to prevent odor nuisance. Separate containers are available for green waste, paper and glass!

Article 16: Sports and games

To protect other people's property, it is forbidden to play ball games in the street. You can play football on the playing field behind the large toilet block, at the panna cage or on the beach behind the dunes. The playground is open daily between 09:00 and 21:00. Dogs, balls, bicycles and glassware are prohibited in the playground.

Digging in the playground is also not allowed.

Article 17: Disorderly Conduct

The management of the campsite reserves the right to permanently deny access to the campsite to persons who behave in a disorderly manner and who ignore the rules.

Article 18: Alcohol and drug use

Consuming alcoholic drinks is only permitted at the place you rented or in the restaurant with associated terrace. Parents or guardians remain responsible for their children at all times and must control or prevent alcohol consumption among them. Alcohol is not served and/or sold to persons under the age of 18. The use of drugs is strictly prohibited at Strandcamping de Zwinhoeve. Persons who do not comply with these rules will be removed from the campsite.

Article 19: Cancellation

In case of cancellation, the HISWA-RECRON conditions apply. You must always inform us of a cancellation in writing.

Article 20: Reception

The mail can be picked up at the reception in the mailbox under the 1st letter of your last name. Mail to be sent can be handed in at the reception.

Opening hours of the reception, the brasserie and the park shop are indicated on the relevant entrance doors. Keep an eye on these, because they are regularly adjusted, depending on how busy the campsite is.
